Limited Warranty

- (b) *THE FOREGOING WARRANTY IS IN LIEU OF ANY AND ALL OTHER WARRANTIES RELATING TO THE SERVICES TO BE PERFORMED OR THE ACCURACY OF THE RESULTS OBTAINED, EXPRESSED OR IMPLIED, INCLUDING, WITHOUT LIMITATION, ANY IMPLIED WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE, OR FOR NON-INFRINGEMENT OF INTELLECTUAL PROPERTY RIGHTS.*

Limitations of Liabilities

- (a) In no event shall Taconic be liable to Client or to any third party claiming by or through the Client for any special, incidental, consequential, exemplary, punitive, multiple or other indirect damages, or for loss of profits arising out of the performance of the services or the failure, negligence, or delay in performance of the services, whether based upon warranty, contract, tort, strict liability or otherwise, even if Taconic has been advised of the possibility of such damages or losses.
- (b) Taconic's liability arising out of the performance of the services or failure or delay to perform the services, whether based upon warranty, contract, tort, strict liability or otherwise, shall not exceed the fee paid by Client for such services.
- (c) An action for breach of this agreement may not be brought by Client more than one (1) year after the services are performed by Taconic
